- 1. The Student Shall be only Eligible for the 100% Refund of the Security Deposit upon Arrival at the University applied by SOH.
- 2. SOH will generate a new E-Mail address for each student applying for admission or a scholarship. Students hereby grant us permission to establish and utilize their Email IDs. However, after the completion of the process (upon receipt of the VISA), the student will be granted access.
- **3.** The student shall bear the Application Fees
- 4. SOH shall not be liable if any course or intake offered by a university is subsequently closed.
- **5.** If the student does not respond within 48 hours of receiving the email, it will be declared Auto-Acknowledged.
- 6. The availability of "Assistance Services is contingent on Profile, Money, Location, and other elements. SOH doesn't guarantee these services.
- 7. If the student fails to get any Offer Letter after the application, then SOH shall provide more options to the students in terms of course, country, university & Intake.
- **8.** In the instances listed below, SOH shall not be responsible for any educational loss or refund. SOH has the authority to terminate the proceeding and close the file:
- **«** If the student will not submit the required documents as per the deadlines given by the Counsellor.
- « If the student is discovered to be affiliated with other consultancies or submitting applications to them.
- « If the student is found doing aforesaid illegal act like providing unauthorized, illegal/ unapproved UGC/NAAC certificates, degree, or any documentation.
- 9. Students should be aware that obtaining a visa is contingent upon the procedures of the relevant embassy. In the event that the visa application is declined for any reason, SOH will not be held accountable in any way
- 10. Students need to be informed that the university has complete control over the terms of the offer letter, including acceptance, rejection, conditions, scholarships, de-ferments, and TAT (turnaround time). Having SOH as your agent will increase your odds, but we cannot guarantee or compel anything to happen.
- 11. The signature MOU from the SOH end (when shared on mail) if not reverted within 48 Hours will be considered Auto-Acknowledged from the student's end.
- **12.** SOH shall not be liable to the student whatsoever in case of non-operation of any cause in this MOU due to any natural calamities, change in government policies, an act of God, or any event beyond human control.
- 13. If the student wants this document to be notarized (on 100/- STAMP PAPER), he/she has to pay 500/- for the same. The original agreement of this MOU will be retained with SOH & soft copy will be sent to the student on his/her official mail.
